**VIII. Public Comments as they relate to items on the agenda.**

**Mr. Anthony Anderson ( Club Onyx)** – addressed the forum concerning proposed Ordinance 2023-01 which would amend Ordinance 2021-02 regulating the operation hours of all places of business where alcoholic beverages were sold, stored for sale at retail, served or consumed.

**Mr. Anthony Anderson-** advised the forum he had concerns on how the change from 3:00 a.m. closing time to 2:00 a.m. closing time would affect his business, and that it seems everything that happens on Winnsboro Road they are held responsible for it; and concerning the incident that happened they have majorly changed the security protocols of his business.

**Mr. Anderson -** asked what is it they must do?

**Alderman Wysinger Cleveland-** said he appreciated the changes which have occurred, but he would like to see the security tightened up, the parking lot area as well.

**Mr. Anderson-** discussed with the forum that since the incident that occurred, major security measures had been put in place, if something is brought to their attention, they do everything possible to make changes.

**Alderman Wilbert Reed Jr.** – stated I think all of us are aware that within the last 60 days there has been an incident, and what I am getting at is this isn't the first time and it won't be the last time when you deal with these types of businesses, within the last 6 months what improvements in security has been made at that location ?

**Mr. Anthony Anderson** – answered, “We added the only metal detector around, you cannot enter the building unless you walk through the metal detector.

**Alderman Leola Keys-** stated, my concern is for the Town and its' citizens, I am going to make a general statement, but it never was the intent of the founders of Richwood to never have Richwood identified with two images, the first image, Richwood being a plantation; the second image being a town where the activities conducted in that town is criminal. We have laws in place, and it is for a specific purpose, there was trouble with a club down on HWY 15, and some way we have got to stop this, we have to enforce our laws.

#### **IX. Mayor's Dialogue :**

**Mayor Gerald Brown** – addressed the forum and shared that this Saturday, April 22<sup>nd</sup> from 8:30 a.m. to 2:00 p.m. the City of Monroe is sponsoring a Blight Boot Camp there will be an opportunity receive information on the Rental Rehabilitation Grant as well as the Healthy Homes Grant, the Healthy homes grant is potentially up to \$ 20,000. Although we are not in Monroe, we can qualify through the parish.

**Mayor Gerald Brown-** advised the forum that Live-Well Delta will be providing a free screening event on Saturday, April 29, 2023 from 9:00 a.m. to 1:00 p.m. there will be a free screening event at the Monroe Civic Center; if you want to participate in this you will need to contact Mary Byrd Cancer Center, their number is 318-414-9758,

**Mayor Gerald Brown-** stated when we met last month Mr. Reed discussed with us the possibility of moving from a town to city status, in those copies Mr. Reed you indicated based on your research we have somewhere around 6,000 population, can I ask where you got those numbers?

**Alderman Wilbert Reed Jr.** – stated, it was online.

**Mayor Gerald Brown-** inquired if it was on the census? Census.gov ?

**Alderman Wilbert Reed Jr.** – replied, no it was an area that had the compilation for including in the incarcerated, I can provide that, I didn't bring it tonight, but I can provide that.

**Mayor Gerald Brown-** replied, “Please do, because based on what I can find out with the Census, the inmate retention numbers are added into their number already, the 2020 Census had us at 3,881 they advised the prison number was already added into it. So, if you got something different than that, I definitely would like to see that.
